

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://thelovinglotus.com/> and The Loving Lotus and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to The Loving Lotus include <https://thelovinglotus.com/>. The The Loving Lotus website is a Blog site. By using the The Loving Lotus website, you consent to the data practices described in this statement.

Collection of your Personal Information

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through The Loving Lotus's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. Sharing Information with Third Parties

In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. Automatically Collected Information

Use of Cookies
